INTRODUCTION

Turība University is an environment where strong personalities grow, develop, and improve, recognizing the value of their knowledge. Already since 1993, the goal of Turība University has been to continuously improve its competitiveness, prestige, and international recognition.

At Turība University, knowledge goes hand in hand with practical skills – a combination highly valued by employers not only in Latvia but also worldwide.

Among Turība graduates, there are successful entrepreneurs, creators of innovative products, athletes, talented artists, and many others, whose examples clearly demonstrate that practically anything is possible! 99.61% of Turība graduates are employed, with more than 80% already working during their studies.

At the university, practical studies make up 60% of the study time, while theory accounts for 40%. The lecturers are industry professionals with extensive practical experience, who, in addition to theory, provide insights into the world of specific sectors.

An internationally recognized diploma, work experience during studies, participation in various projects and conferences, internships abroad, the acquisition and enhancement of practical knowledge in one of the faculty's specialized learning spaces (courtroom, StartUP Hotel), a business incubator for starting a business, and the creation of valuable contacts all ensure that everyone has the opportunity to achieve their goals!

The university offers 27 study programs, 14 of which are available in English. Students from more than 40 countries study here.

To promote the university's scientific activities and the competitiveness of enterprises, to develop the university's intellectual potential, and to enhance study programs in line with modern scientific achievements, Turība University was granted the status of a scientific institution on March 6, 2020, and was included in the Register of Scientific Institutions.

Currently, Turība University conducts applied research, provides consulting services, participates in national and international research projects and programs, coordinates the university's scientific activities, organizes scientific conferences, seminars, and lectures, as well as publishes research results and other informational materials.

The university's main niche is creating connections between businesses that want to introduce new products to the market and researchers whose research results can be commercialized and brought and introduced to the market.

Applied research is carried out in four scientific areas. A large number of research projects focus on business management and Latvia's priority sector — tourism. One of the long-term goals is to participate in research on modern technologies and their development. An important aspect is the promotion of research results and innovations in the business environment, primarily in Latvia.

Scientific research is funded from various sources: the university's budget, European Union funds, as well as other international programs.

Turība University also works on exploring new technological solutions and applications, as well as their economic justification, in order to promote business development and innovation. The university collaborates with various national and international associations, government and local authorities, businesses, and educational institutions in both Latvia and abroad. The institute's activities focus on improving the business environment in Latvia and, with the help of international projects, as well as in other European Union countries. The project network is used as a collaboration tool for transferring new technological solutions to SMEs in other EU countries. The exchange of experience through this collaboration network promotes innovative entrepreneurship, boosting SME productivity and competitiveness.

The university's vision is: We are the ideological core and driving force of Latvia's future economy. Its mission is: We drive business thinking worldwide, earning for ourselves and teaching others to earn.

SUMMARY OF THE UNIVERSITY'S SCIENTIFIC ACTIVITIES RESULTS FOR YEAR 2020

At Turība University, scientific research activities are directly linked to the university's doctoral studies. The university offers four doctoral study programs:

- **Communication Management**, program director: Dr. phil., Prof. Ainārs Dimants, authorized to run the program since July 31, 2012.
- Law, program director: Dr. iur., Una Skrastiņa, authorized to run the program since May 3, 2011.
- Management Science, program director: Dr. oec., Prof. Rosita Zvirgzdiņa, authorized to run the program since August 5, 2014.
- Business Administration, program director: Dr. oec., Prof. Rosita Zvirgzdiņa, authorized to run the program since August 5, 2014.

According to the Law on Scientific Activities, a university can be delegated the right to confer doctoral degrees in a specific scientific field if it meets three conditions: the university implements an accredited doctoral study program corresponding to the field of science, at least three experts approved by the Latvian Science Council are involved in the program's implementation, and the Latvian Science Council has provided an opinion on the possibility of delegating the right to confer doctoral degrees in the respective field.




Figure 1. The total number of scientific publications.

The university's scientific research activity and quality are confirmed by a total of 52 publications (Figure 1). The majority of publications were prepared by the faculty members of the **Faculty of Business Administration** – 25 publications, or 48%. Faculty members of the **Faculty of Law** prepared 13 publications, or 25%, and faculty members of the **Faculty of International Tourism** prepared 14 publications, or 27%.

Of the 62 publications in 2020, 29 have already been indexed in SCOPUS or Web of Science databases (see Figure 2).




Figure 3 . Participation of lecturers in conferences.

During the reporting period, faculty members participated 32 times in scientific conferences, forums, and seminars, where they presented papers or expressed their views on current topics in society (see Figure

3).

On April 24, 2020, Turība University hosted the XXI International Scientific Conference "LONG-TERM ECONOMY. THE LATVIA STORY."

The conference was attended by experts from Singapore, the United Kingdom, Denmark, India, Pakistan, Georgia, Germany, Lithuania, and Latvia.

The goal of the conference was to identify and discuss ways to promote the long-term development of the Latvian economy. It aimed to explore methods for successfully overcoming crises and attracting investments during crisis situations to recover more quickly and increase the country's competitiveness in export markets.

During the conference, the experience of Singapore was analyzed, which has seen impressive economic growth over the past 30 years. The steps taken by Singapore during its development period were discussed, with a focus on what Latvia could adopt to accelerate its own development. The scientific proceedings of the XXI Conference have been published and indexed in internationally cited databases such as EBSCO, Business Source Complete, Business Source Corporate Plus, and ProQuest, as well as published on the Turība University website.

In 2020, the Turība University published its scientific journal **Acta Prosperitatis No. 11, ISSN 1691-6077**. The editorial board includes members from Latvia, Turkey, Russia, Slovakia, Serbia, Poland, Denmark, the Czech Republic, Sweden, Germany, and Lithuania. Besides Turība University, other contributing institutions include the University of Turkish Aeronautical Association (**Turkey**), University of Wrocław, Nicholas Copernicus University, Wroclaw University of Economics (**Poland**), Uppsala University (**Sweden**), Leibniz University Hannover, Berlin Social Science Center (**Germany**), Mykolas Romeris University, Vilnius University, Kaunas University of Technology, Vytautas Magnus University (**Lithuania**), University of Economics and Management Prague (**Czech Republic**), Žilina University (**Slovakia**), University of Novi Sad (**Serbia**), Moscow State Institute of International Relations (**Russia**), and the European Integration Institute (**Denmark**).

THE MAIN RESEARCH FIELDS

The qualitative contribution and funding of scientific research work, both in the short-term and long-term periods, are determined by the strategic guidelines of Turība University for 2016-2020. One of its tasks is to prepare doctoral candidates, which is a practical realization of the Education Development Guidelines for 2014–2020, with the aim of ensuring quality education for the improvement of individual skills, thus promoting the development of professional and social skills for life and competitiveness in the labor market.

The key tasks for the university's scientific activities in the coming years are:

- to promote research work and publication in internationally cited journals;
- to support and encourage the development of staff through international programs, participation in projects, and expanding practical experience;
- to promote the activity and visibility of staff in business, scientific, and public spheres;
- to attract the most outstanding students, lecturers, and professionals to create products significant to the national economy.

The funding for scientific work in 2020 comes from the university's science budget, payments for research commissioned by public administration institutions, and the European Union structural funds.

The daily work of lecturers is not only about leading lectures and seminars and advising students. An important part of Turība University staff members' work is to enhance their academic competence by publishing research, collaborating with employers, and participating in working groups aimed at researching specific issues, promoting the introduction of innovation into business, and ensuring the prosperity of the national economy. Applied research, carried out in collaboration with industry experts and students, will be useful for any employer, helping them keep track of industry trends and plan the company's future development. Research is conducted in four scientific fields. A large portion of the research projects are in the field of business management and Latvia's priority sector—tourism.

attend these services, as they are only recommended, not mandatory. Additionally, the

Adviser: Ivo Krievs

The aim of the work is to investigate the threat posed by ransomware, draw

conclusions, and develop suggestions for the company's response before and during

a ransomware attack. The study concludes that preparation for a ransomware incident

is possible, and with the implementation of appropriate security measures, such

incidents can be prevented.

The work consists of three chapters, which explore the concept of ransomware, its

operation, and its impact on the company's systems. It also covers the types of

company systems and their vulnerabilities, countermeasures against ransomware,

aspects of risk management, the company's actions during a ransomware attack,

incident management, actions in the case of a data protection breach, as well as the

accounting and legal aspects of ransom payments.

Topic: Proving the elements of money laundering

Adviser: Juris Juriss

The aim of the master's thesis is to explore the criminal law characterization of money

laundering from both theoretical and practical aspects, identify problematic issues, and

propose potential solutions. Upon achieving the goal of the thesis and fulfilling its

objectives, conclusions will be drawn and recommendations will be made, aimed at

more effective evidence of the elements of money laundering.

Agta Kandavniece

Topic: Transactions with agricultural land and the application of the law

"On Land Privatization in Rural Areas"

Adviser: Liene Cakare

The goal of the paper is to identify the shortcomings of the legal regulation of

agricultural land transactions and to develop proposals for improving the legal

framework. Transactions with agricultural land and the application of the "Law on Land

Privatization in Rural Areas" is a broad topic that can be viewed from different

perspectives. However, this paper will mainly focus on the conditions that the subjects

specified in the law must meet and their transactions with agricultural land, as well as

the process of concluding the transaction and general concepts. The provisions of the

law "On Land Privatization in Rural Areas" will be analyzed within the period from

August 1, 2014. The paper mainly discusses the legal framework of the law "On Land

Privatization in Rural Areas" and Cabinet Regulation No. 748 of December 2, 2014,

"Regulations on Transactions with Agricultural Land." The paper will not address the

acquisition of agricultural land for the extraction of minerals.

Sannija Matule

Topic: Journalists' Rights to Receive Information in Criminal Proceedings

and Access to Criminal Case Materials

Adviser: Sigita Martinsone

The goal of this master's thesis is to conduct independent research, analyzing the legal

framework and developing proposals for amendments to the Criminal Procedure Law,

aiming to improve the national regulatory framework concerning journalists' access to

information. The study confirms the hypothesis that the Criminal Procedure Law does

not provide a balance between the public's right to information, on the one hand, and

the interests of the investigation, as well as the protection of individuals' fundamental

rights, on the other hand. The author offers specific proposals for addressing the

problems identified during the research.

Natalja Arikāne

Topic: The application of Value Added Tax (VAT) in construction and its issues

Adviser: Nikolajs Ozoliņš

The aim of the thesis is to develop conclusions and proposals for the improvement of

the legal acts regulating the application of Value Added Tax (VAT) to construction

services. Through the research work, the author concluded that in order to resolve the

issue being studied, it is necessary to improve the legal acts that regulate the

application of VAT to construction services.

Kristīne Lāce

Topic: The compliance of pharmaceutical wholesalers' operations with

competition law principles

Adviser: Mārtiņš Martinsons

The aim of the research is to assess competition law violations in the pharmaceutical

sector in Latvia and to develop proposals for the improvement of the legal framework.

By analyzing the activities of participants in the Latvian pharmaceutical market, it can

be concluded that, despite the relatively large number of wholesalers, the existing

market players are not strong enough to exert effective competitive pressure on market

leaders. One of the factors creating significant barriers to the entry of new competitors

and strengthening the position of existing market participants is the existence of

vertically integrated pharmaceutical retail networks among the largest wholesalers,

specifically the large pharmacy chains. The presence of vertical integration and the

limited number of direct contracts (up to exclusivity) with pharmaceutical

manufacturers also creates the risk of excluding competing pharmacies from the

market. The most common type of unfair competition violation in Latvia's

pharmaceutical sector is the abuse of a dominant market position and mergers. The

increase in market concentration essentially leads to a situation where consumer

choice decreases, while leading market players find it easier to influence drug prices.

Zane Veinberga

Topic: The legal regulation of multi-apartment house management and its

problematics.

Adviser: Nikolajs Ozoliņš

The thesis analyzes the sector's regulatory framework, case law, and legal scholars'

insights, using the author's previous research on multi-apartment house management,

issues related to the collection of utility payments, and possible solutions,

supplemented with the author's professional experience and the current relevance of

the topic. The aim of the thesis is to provide recommendations for amendments to the

Residential House Management Law, the Apartment Ownership Law, and the

improvement of other regulatory acts governing the multi-apartment house

management sector.

Topic: The evaluation of business and event tourism in Riga and Jurmala:

theory and practice

Adviser: Agita Donina

The study evaluates the business and event tourism in Riga and Jurmala for the years

2018 and 2019 by developing assessment criteria. The findings of the research suggest

that although in 2019 there were 94 fewer MICE (Meetings, Incentives, Conferences,

and Exhibitions) events in Riga and Jurmala compared to 2018, the number of

participants in 2019 increased by 40%, and total revenue grew by €2,435,167 compared

to 2018. Conferences and congresses, despite having fewer events, attract the highest

number of participants, as evidenced by the fact that 50% of the total MICE revenue is

generated by conferences.

Beāte Vilciņa

Topic: The recognition of tourist attraction created by Pvt. "Latvijas valsts

meži"

Adviser: Daina Vinklere

The study conducted an evaluation of the recognition of tourist attractions created by

Pvt. "Latvijas valsts meži" in Latvia, a topic that has gained significant relevance in a time

when a growing number of people engage in outdoor leisure activities. The author has

calculated indicators for the recognition of the tourist attractions developed by the

company, determining both spontaneous recognition and aided recognition indicators.

This process also involved analyzing the opinions of local municipalities from various

regions of Latvia, tourism information centers, and LVM itself. Based on the findings, the

study provided suggestions aimed at improving the effectiveness of marketing activities

for all involved parties.

Topic: The development of the trail running event "Stirnu buks"

Adviser: Daina Vinklere

The aim of the study is to evaluate the development of the trail running series "Stirnu

buks" from its beginning in 2014 and to provide recommendations for its future

organization. The research is based on document analysis, interviews with event

organizers, and surveys of event participants. The study's findings highlight significant

progress in both the organizational aspects and the number of participants. At the same

time, the growth has introduced new challenges, which the author addresses by offering

specific recommendations, taking into account the suggestions of the involved parties.

The study evaluates the experience of tourism and hospitality businesses in Riga in

working with international students in terms of internships and employment

draws conclusions about the benefits and challenges for the involved parties and offers

suggestions for improving the situation.

Topic: Human resource management challenges in Latvia when

working with Generation Z

In the research, theoretical materials on Generation Z, its distinctive characteristics,

and the challenges it presents to human resource management specialists are

explored. The study concluded that the main challenges faced by companies are

employee turnover, attracting and retaining the new generation, workplace culture,

bonus systems, and communication issues. For Generation Z, important aspects in

the workplace include compensation and the internal environment, ensuring it is

ergonomic and modern. Members of Generation Z tend to be individualistic, as they

prefer working independently rather than in teams. Communication also differs from

previous generations, as the younger generation prefers digital environment.

Topic: The organization of vow renewal ceremonies on cruise ships

The aim of the study is to evaluate the specifics of organizing the popular USA event
