## **INTRODUCTION**

Turība University is the largest private university in the Baltic States. Turība University is an environment where strong personalities grow, develop, and perfect themselves, recognizing the value of their knowledge. Turība University is a progressive, modern environment that keeps pace with the times. Since 1993, the goal of Turība University has been to continuously improve its competitiveness, prestige, and international recognition.

At Turība University, knowledge goes hand in hand with practical skills – a combination highly valued by employers not only in Latvia but also worldwide. Turība inspires young people to be entrepreneurial and to implement their ideas, while encouraging them to operate not only at the national level but also internationally. For a successful and idearich entrepreneur, national borders do not exist – creativity and entrepreneurship transcend them!

Among Turība's graduates are successful entrepreneurs, creators of innovative products, athletes, talented artists, and many others, whose examples clearly show that practically anything is possible! 99.61% of Turība graduates are employed, with more than 80% working during their studies.

At the university, practical studies make up 60% of the study time, while theory accounts for 40%. The lecturers are industry professionals with extensive practical experience who, in addition to theory, provide insight into the specific industry.

An internationally recognized diploma, work experience during studies, participation in various projects and conferences, internships abroad, acquisition and refinement of practical knowledge in one of the faculty's specialized learning environments (courtroom, StartUP Hotel), a business incubator for starting a business, and the creation of valuable contacts ensure that everyone has the opportunity to achieve their goals!

The university offers 29 study programs, 13 of which are also available in English. Students from more than 40 countries around the world study with us.

- Faculty of International Tourism
- Department of Information Technology.

The university has three branches: in Liepāja, Cēsis, and Talsi.

Nothing is as constant as change – the year 2021 has clearly proven the truth of this concept, yet Turība University, with its over 28 years of activity, has demonstrated the ability to adapt not only to continuous changes but also to ambiguous competitive conditions. Turība University holds the status of a scientific institution and is included in the Register of Scientific Institutions. As a scientific institution, the university sets a goal to ensure research activities in social sciences and interdisciplinary research areas that align with strategic objectives and research program priorities, promote the unity of science and higher education, create new knowledge, and contribute to the development of these scientific fields.

Turība University currently conducts applied research, provides consulting services, participates in national and international research projects and programs, coordinates the university's scientific activities, and organizes scientific conferences, seminars, and lectures. Research results are published, and the scientific staff's publication in peer-reviewed journals included in Web of Science, SCOPUS, ERIH+, and other international scientific databases is supported.

The university has created a long-term collaboration platform for scientists and entrepreneurs, with a niche in establishing connections between businesses that want to introduce new products to the market and researchers whose findings can be commercialized and pushed to the market.

Applied research is conducted in four scientific areas. Many of the research projects are in business management and Latvia's priority sector – tourism. One of the long-term goals is participation in research on modern technologies and their development. An important aspect is the promotion of research results and innovations in the business environment, primarily in Latvia.

Scientific research is funded from various sources: the university's budget, European Union, and other international programs.

Turība University is also working on the exploration and economic justification of new technological solutions and applications to promote business development and innovation. The university collaborates with various national and international associations, state and municipal institutions, businesses, and educational institutions both in Latvia and abroad. The institute's activities are aimed at improving the business environment in Latvia and, with the help of international projects, in other EU countries. The project network is used as a collaboration tool

for transferring new technological solutions to SMEs in other EU countries.

Experience exchange through the collaboration network promotes innovative entrepreneurship, increasing the productivity and competitiveness of SMEs.

## **DESCRIPTION OF SCIENTIFIC STRUCTURE AND SCIENTIFIC PERSONNEL**

At Turība University, scientific research activities are directly linked to the university's doctoral studies. The university offers four doctoral study programs:

According to the Law on Scientific Activities, a university can be delegated the right to confer doctoral degrees in a specific scientific field if it meets three conditions: the university implements an accredited doctoral study program corresponding to the field of science, at least three experts approved by the Latvian Science Council are involved in the program's implementation, and the Latvian Science Council has provided an opinion on the possibility of delegating the right to confer doctoral degrees in the respective field.

## THE MAIN RESEARCH FIELDS

The qualitative contribution and funding of scientific research work, both in the short and long term, are determined by the strategic guidelines of Turiba University for 2021–2025. The close connection between the study process and scientific activities conducted at the university is a crucial prerequisite for the preparation of highly skilled specialists, the development of excellence, and the university's international cooperation. With the support of the university, the quality level of academic staff's research activities improves, resulting in research outcomes being reflected in publications in high-quality journals (Q1 and Q2), including collaborations with foreign authors. In the previous 2022/2023 academic year, there were six publications in Q1 and Q2 journals, while this academic year, there are nine. This demonstrates that the academic staff of the Turība University is capable of producing scientific publications that meet international standards. Doctoral students are also actively involved in scientific research. A significant number of publications, approximately 30% of the total, have been prepared in collaboration with the doctoral thesis supervisor or scientific consultant.

### STUDENTS' RESEARCH ACHIEVEMENTS (evaluation outside Turība University)

**Turība University first-year Business Management students Ralfs Ronis and Daniels Milčs have created a unique business idea aimed at improving pedestrian safety and reducing traffic accidents at pedestrian crossings.** Daniels and Ralfs jointly established the company "Danra SEEMI" and presented their idea in the business idea competition "Biznesa skices" organized by Swedbank, where they reached the third round of the competition.

**From February 2 to 3**, a European Council simulation game, ConSIMium, was held in Brussels for students, with participants from Turība University. 27 teams from various European Union member states gained experience and learned about decision-making in European Council meetings.

In the Latvian Restaurant Association's scientific paper competition for university students, **Luka Sharvashidze** (a 2023 graduate of the "Tourism and Hospitality Management" program) won third place.

**Mykhailo Antropov**, a third-year IT student from Ukraine at Turība University, in collaboration with the university's IT department scientists, has developed an application for a unique device that reads low-frequency brain radio waves and can control equipment to make it move in various directions. This marks a significant development in combining technology with the human mind.

**Title of invention:** A method and system for controlling computerized text input using a brain-computer interface

**Short description:** The invention relates to a method and system for controlling text input to assist people in performing tasks using a brain-computer interface, utilizing brain activity analysis as a response to visual stimuli. Specifically, it involves a text input control system that receives an EEG signal from the user, indicating their intention to initiate the system's operation. The system then provides the user with visual stimuli that sequentially highlight individual alphabet characters, which include distinct signal cycles associated with character selection. The system subsequently detects the EEG signal caused by the visual stimulation, enabling the identification of the character chosen by the user through the analysis of the P300 component.
